1. Purpose

1.1 This Policy is to provide a framework and guidance by which Council shall deal with proposals to name public infrastructure or acknowledge individuals or organisations publicly.

2. Scope

2.1 This policy relates to the naming of public infrastructure and acknowledgement of individuals or organisations within the Shire of Gunnedah and shall include but not be limited to a public place, facility, building, structure, statues, services infrastructure and areas or items of flora under the control of Gunnedah Shire Council.

3. Definitions

3.1 *Council* means Gunnedah Shire Council

Immediate family in this policy means a deceased persons next of kin.

Public Infrastructure means any facility or structure which is owned and/or managed by the Gunnedah Shire Council shall including but not be limited to a public place, facility, building, structure, statues, services infrastructure and areas or items of flora.

4. Policy Principles

4.1 This policy intends to provide methodology to identify Individuals or organisations within the Gunnedah Community to recognise contributions to develop a list of potential names that could be used for the naming or public infrastructure such as, bridge, parks or road within the Gunnedah Local Government Area.

5. Policy Statement

5.1 Nominations

- 5.1.1 Nominations for naming of infrastructure or acknowledgement of individuals or organisations must be made in writing to Council. Submissions shall contain a detailed justification as to why the nominated item should be named as proposed and the background to the use of the proposed name.
- 5.1.2 Nominated names which are accepted by Council, but where no specific item of public infrastructure is nominated, names will be included within Council's 'Naming of Public Infrastructure Register'.

5.2 Process

5.2.1 Nominations shall be reported to Council for assessment as to whether the proposal shall proceed to public advertising. Council may refuse the proposed naming at this stage based on its assessment of the submission.

- 5.2.2 Following acceptance of a submission by Council for naming of any particular infrastructure, the submission shall be advertised in a local newspaper for a period of 21 days inviting comment and/or objections to the proposed naming.
- 5.2.3 Where the proposal relates to a living person, Council shall enquire as to that individual's concurrence to the proposal.
- 5.2.3 Where the proposal involves a deceased person, and the immediate family can be contacted, Council shall enquire as to the family's support for the submission.
- 5.2.4 Following closure of the exhibition period Council shall consider any submissions and determine whether the naming of infrastructure or the public acknowledgement of the individual or organisation shall be approved.

5.3 Limitations

5.3 The endorsement of names within Council's 'Naming of Public Infrastructure Register' does not ensure that the name is acceptable for the purpose of naming of public infrastructure. Any registration of public infrastructure with such a name would need to comply and be accepted by the Geographical Names Board in accordance with the 'Geographical Names Board of NSW Policy – Place Naming'.
