Application	<ul style="list-style-type: none"> o Applicant must submit a plan of the proposed works along with a signed declaration that information supplied to Council is correct.
Permit Conditions	<ul style="list-style-type: none"> o All excavations must be protected using warning signs and barricades in accordance with Australian Standard AS1742.3 Traffic Control Devices for Works on Roads and must comply with the provisions of the NSW Work Health and Safety Act 2011. o Confirmation of locations of underground services via Dial Before You Dig (1100) or other means must be sought prior to excavation and is the responsibility of the applicant. o The excavator must display a sign prominently identifying the person or body responsible for the work and a 24 hour contact phone number. o For work on or near RMS Regional or State Roads, an RMS Occupancy Certificate must be obtained prior commencement and must be available on-site for inspection for the duration of the works (see attached list of State and Regional Roads). o All surplus material other than that required for settlement must be removed at once from the site. All material obtained from a road reserve are to be contained within a road reserve unless stockpiled and tested in accordance with Roads Act 1993 and RMS requirements. o Council's Infrastructure Department must be informed immediately on completion of all works to arrange a site inspection and measurement of completed works – telephone (02) 67402100. o Any additional fees identified during site inspection, must be paid within 7 days of notification from Council. <i>Please note:</i> A late fee, as outlined in Council's Fees and Charges, may be applied after the due date. The late fee will automatically be charged if any additional area is identified by routine inspection and/or the permit holder has failed to notify Council of completion of the works. o Failure to make the excavation site safe during and after construction will result in Council carrying out all works deemed necessary at full cost to the permit holder. o A copy of this Permit must be kept on site for inspection by authorised officers. Penalties apply for unauthorised excavations in Council assets. o All Council footpaths adjacent to service stations are potentially contaminated with petrochemicals. Contractors are required to exercise caution and adopt appropriate WH&S measures and ensure appropriate exposure controls are in place. o If the backfilling of the trench is not carried out in accordance with the specification, the permit holder will be liable for any extra costs incurred by Council in rectification work. If the trench subsides at a future date due to unsatisfactory backfill, the utility authority or permit holder will be liable for the cost of any required rectification work. o This permit does not grant the holder permission to carry out permanent restoration. Permission to carry out permanent restoration must be sought in writing from Council. All applications for permanent restoration will be considered on a case by case basis and will be subject to conditions.
